You commit only to the credits you attempt, and pay when you attempt them. This pricing model offers more flexibility but ultimately results in a higher total cost than in the program-based model.

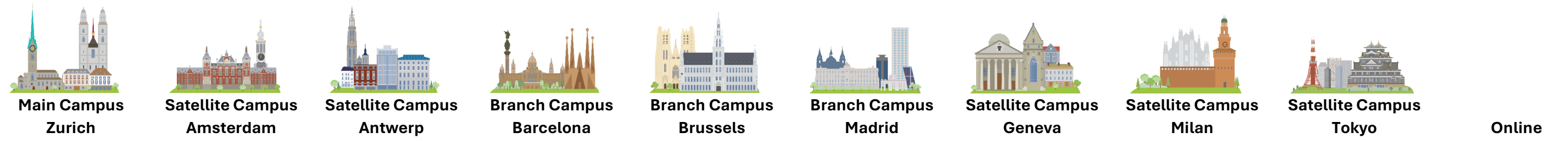
Academic fees apply to specific academic or administrative actions requested by a student. Applicability and timing are defined per fee below.
The following fees are charged in the respective campus currency if not specified explicitly.

student application	100 CHF

program change	500 CHF + 25 CHF per credit attempted
program withdrawal (program-based pricing)	2.000 CHF + 50% of the additional credits fee per credit remaining (capped at 60 credits)
program withdrawal (credit-based pricing)	minimum deposit + 100% of the pay-per-credit fee for each credit enrolled in the quarter following the withdrawal request (minimum 10 credits)
